**BATH AND NORTH EAST SOMERSET COUNCIL (PUBLIC FOOTPATH CL16/56,
WESTVIEW, PAULTON) PUBLIC PATH DIVERSION ORDER 2023**

This order is made by Bath and North East Somerset Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owners of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

BY THIS ORDER:

1. The public right of way over the land situate at Westview, Paulton and shown by a bold continuous line on the map contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after seven days from the date of confirmation of this Order.
2. No statutory undertakers rights are affected by this order.
3. There shall at the end of seven days from the date of confirmation of this order be a public footpath over the land situate at Westview, Paulton described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this order.
4. The rights conferred on the public under this order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

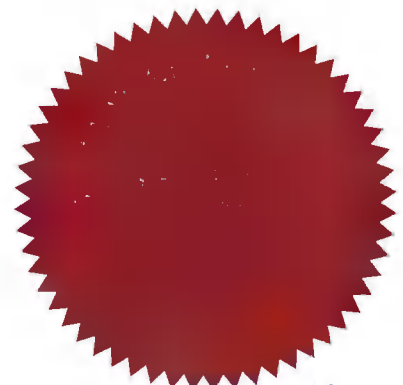

SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

The full width of the section of Public Footpath CL16/56 commencing from grid reference ST 6436 5638 (point A on the Order Map) and proceeding in a generally easterly direction for approximately 60 metres to grid reference ST 6442 5637 (point B on the Order Map), and then turning in a generally northerly direction for approximately 8 metres to grid reference ST 6442 5638 (point C on the Order Map)

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY

A public footpath commencing from grid reference ST 6436 5638 (point A on the Order Map) and proceeding in a generally easterly direction for approximately 58 metres to grid reference ST 6442 5638 (point C on the Order Map).

Width: 2 metres between grid references ST 6436 5638 (point A on the Order Map) and ST 6442 5638 (point C on the Order Map).
