	CS – most cattle aren't aggressive but there's always the exception. There are lots more incidents with cars compared with cattle. Members of the public should carry a stick when walking in fields with livestock.	
E3	Election of Chair for Next four month period PB proposed KT for chair and DM for vice-chair; AF seconded both; both was elected in unanimously.	
E4	Any Other Business	
	Rural Bus Network: In some areas the Council have found the necessary funding for rural buses to continue. Often these networks start off voluntarily but funding then dries up, so they need to be self-funding to continue. AF – the projects that were circulated since the last meeting have been keep going because they've been self-funding. KT – Keynsham TC has secured funding to buy mini-buses.
