

Joint Local Access Forum (JLAF)

for Bath & North East Somerset, Bristol City and South Gloucestershire

The Joint Local Access Forum Terms of Reference

Title

1. The Forum shall be known as the Joint Local Access Forum (“JLAF”).
2. The Forum will be the Joint Local Access Forum for Bath & North East Somerset, Bristol City and South Gloucestershire (the Councils for which areas are called “the Constituent Councils”).

Role and Responsibilities

3. The primary purpose of the Joint Local Access Forum is to provide relevant advice:

a) about the improvement of public access to land in the area for the purposes of open-air recreation and the enjoyment of the area, and

b) about public access to land in the area for “any lawful purpose” (not already specified.) (For mechanically propelled vehicles this further matter is limited to access to byways open to all traffic.)

in ways which address social, economic and environmental interests to the prescribed bodies namely:

the Constituent Councils; the Secretary of State; Natural England; the Forestry Commission; English Heritage; Sport England (the English Sports Council); Areas of Outstanding Natural Beauty (AONB) Conservation Boards and Parish and Town Councils.

The JLAF will assist access provision, giving advice on issues of particular local relevance.

4. The JLAF will give advice on three main topics:

a) implementation, management and review of the statutory rights of access to the countryside;

b) improving the network of rights of way and other routes with public access;

c) the development of strategies that facilitate access to land for recreation and other lawful purposes which cater for a wide variety of people.

5. The JLAF will work to:

- a) develop a constructive and inclusive approach to the topics in Paragraph 3;
- b) respect local circumstances and different interests while operating within national guidance;
- c) provide advice on issues of principle and good practice which is consistent with national guidance;
- d) engage in constructive debate and seek consensus wherever possible;
- e) where consensus is not possible, make clear the nature of differing views and suggest how they might be resolved.

6. In carrying out the functions in paragraph 5 above, the JLAF shall have regard to:

- a) the needs of land management
- b) the desirability of conserving the natural beauty of the area for which it is established, including the flora, fauna, and geological and physiographical features of the area;
- c) guidance given from time to time by the Secretary of State;
- d) proper liaison with neighbouring authorities;
- e) consultation with adjoining Local Access Forums.

Annual Report

7. The JLAF shall produce an Annual Report at the end of each year of its meeting outlining and reviewing its work. The Annual Report shall be published by the Constituent Councils.

Membership

8. The membership will:

- a) be balanced to avoid dominance by any single interest group or coalition of like interests; and
- b) include a cross section of local interests in the countryside. The membership will consist of up to a maximum of 21 members including:
- c) three elected members nominated one each by the Constituent Councils (called "Council representatives"); and
- d) up to 18 other members.

9. Membership of the Joint Local Access Forum will be for a term of up to three years save that:

a) a member replacing another member who has retired, been replaced or otherwise vacated membership will be member for the duration of the term left for the person replaced;

b) at the end of the relevant period any member can be re-appointed;

c) the three Council representatives shall be appointed to the Joint Local Access Forum by the Constituent Councils on a 12 month appointment;

d) a Council representative may appoint a substitute to attend any meeting on his/her behalf.

10. Any member who has been absent from all meetings of the Joint Local Access Forum for a period of one year or fails to comply with the requirements of paragraph 11 below may be removed from the Joint Local Access Forum by the Constituent Councils.

11. Any member who is directly or indirectly interested in any matter brought up for consideration at a meeting of the Joint Local Access Forum shall disclose the nature of his or her interest to the meeting.

12. The Chair will hold office initially for one year and will be appointed by the Joint Local Access Forum at its first meeting held in that year.

13. The Joint Local Access Forum will appoint a Vice Chair to chair any meeting, or part of any meeting as appropriate, when the Chair is unable to attend or has to leave the meeting for any reason.

14. The Chair may suspend any meeting if the meeting falls below a quorum of one third of members currently appointed and/or nominated.

15. The Joint Local Access Forum shall take steps to ensure that the Chair and Vice Chair do not represent similar interest groups.

16. A member of the Joint Local Access Forum may resign by notice in writing to the Constituent Councils which appointed him.

Administration

17. Meetings will be held at least twice a year and more frequently when necessary. The venue will rotate amongst the Constituent Councils unless otherwise decided by the Joint Local Access Forum and will not necessarily be a municipal building.

18. There will be a Secretary who will be a dedicated officer employed by Bath and North East Somerset Council on behalf of the Constituent Councils, who will have responsibility for:

- a) distribution of papers;
- b) arranging and publicising meetings;
- c) liaison between the Joint Local Access Forum, the constituent Councils and Natural England;
- d) contact with all adjoining Forums;
- e) completing the Annual Report.

19. Meeting agendas will be agreed between the Chair and the Secretary. They will be distributed one week before any proposed meeting (except in case of emergency) and all papers for inclusion on an agenda will be submitted for the Secretary three weeks before any proposed meeting (except in case of emergency).

20. Meetings will be advertised in advance and held in public. Except with the permission of the Chair they shall not be recorded or broadcast.

21. Agendas, papers and minutes of the meeting will be available to the public.

22. The Chairman may invite observers to the meeting when appropriate. The Constituent Councils and Natural England will have a right to send observers to any meetings.

23. Observers will be able to contribute at the meeting at the discretion of the Chair.

24. The public will be able to ask questions on the business of the meeting at the discretion of the Chair.

25. The Constituent Councils will have the right to review the chairing and membership of the Joint Local Access Forum if necessary, including to ensure that the requirements of paragraph 8 are being met.

26. The Joint Local Access Forum may decide to set up such committees, subcommittees and working parties as it considers necessary and they will be subject to the same rules (altered as necessary for the circumstances) as the Joint Local Access Forum.

27. These Terms of Reference can be amended by the Joint Local Access Forum from time to time to suit changing circumstances subject to the Constituent Councils all having approved any changes before they come into force.

28. The Joint Local Access Forum shall comply at all times with the requirements for Regulations 6, 7, 8, 9 and 10 of The Local Access Forums (England) Regulations 2007.
