Actions from Previous Meeting

- York St/ Archway Project Felt that a further piece of work in relation to assessment of the weak structure is now required together with an assessment of risk to users within the vaults.
- Approach speeds consideration outstanding. To be considered as part of the design process and brought back to steering group.
- Roman Baths event bookings in 2020/21.

Current Situation

- Access restriction now in place 10am to 6pm daily across 5 pedestrian zones
- Temporary protection measures comprising concrete blocks and gates in place at entrance to York St/ Cheap St and Upper Borough Walls
- Communication and security protocols in place to ensure appropriate operation and control, with suitable resource on site and CCTV control room settings.
- Generally, well received and observed, although has provided some challenges not considered previously.

Stakeholder Consultation

- Initial round of consultation with internal B&NES Teams now complete. Further consideration required in some areas.
- Further meeting required with Independent Equality Advisory Group and St Michaels Day Centre to understand any feedback on temporary access restrictions.
- Further discussion with Police CTSA's on the ATTRO timings.
- VT/ AB stakeholder consultation

Progress Update

- Extensive engagement with Heritage Team through a series of workshops and recent on-site meeting. ST/ SF and WM leading.
- Age UK St Michaels Day Centre highlighted further the difficulty of retaining services for elderly in the city centre. Further consideration required, as the project progresses.
- Proposed form of signage and internal TRO within the pedestrian zones, requested advice from DfT, no response to date.
- Site investigation until after consultation and ATTRO advisement.
- Traffic Studies still required? Require further work on loading outside of pedestrian zones and BBH occupancy within B&NES car parks, Southgate and Podium.
- VT suggested having a separate programme for the design element to chart against the consultation programme.

Project Costs (Capital & Revenue) & Financial Governance

- Capital cost (phases 1-4) circa £2.8M
- Revenue costs circa £110k/ annum.
- 2019/20 Financial headlines Budget £673,884; Spend £170,478 (£61,992 transaction???)
- £550,000 c/f into 2020/21 less £46,593 spend above budget leaving £503,407
- £385,000 was then rephased into 2021/22, leaving £118,406
- 2020/21 Financial headlines Budget £118,406; Spend (to date) £52,723

 Draft amended "Project Plan" gateway to include various approvals, particularly those around HVM design and designer's risk assessments.

Other Project Priorities

- York St/ Archway Project
 - A full street closure proposal has been put forward for the following reasons: -
 - Weak highway structure at the western end of the street. A further piece of work is required in relation to assessment is now required together with an assessment of risk to users within the vaults.
 - inability for larger vehicles to turn around, requiring them to reverse.
 - The number of visitors is expected to rise as a result of the Learning Resource Centre, comprising mainly groups of school children.
 - Table and chair licenses now in place for several businesses.
- Great Drain works and future maintenance.

Access Restrictions

- Discussion on ATTRO timings. Should they be promoted in line with current 10am-6pm timings or retained?
- 9am-7pm could have impact on waste collection, with increased cost to operations as a result of starting earlier. Private companies may have issues with tachographs/ working time directives. Potential noise as a result of starting earlier.
- Communications/ protocols/ mitigations. Largely complete as a result of the temporary access restrictions but will require some changes and additions to suit permanent restrictions.
- Incorporate extension of closure between 6pm 10pm and consideration of similar requests.
- Traffic studies for loading bay usage and BBH requirements outside the pedestrian's zones.
