# ALLOCATION STATEMENT FOR MARKSBURY C of E PRIMARY SCHOOL

#### **PLACES AVAILABLE: 15**

As Marksbury C of. E Primary School was oversubscribed it was necessary to use the Academy Trust's admissions criteria, as published in 'A Primary School for Your Child – 2025/26', to allocate the places available at the school. Applications for all schools are considered under an equal preference system which means that all preferences (1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup>) for each school are considered equally. If there are any cases where more than one of the school preferences named on the application form could have been met only the highest preference school has been allocated.

A total of **28 preferences** were originally received for Marksbury C of E Primary School which has a published Admission Number of **15.** 

If, under any of the categories listed, places were offered and refused, priority was given to those who live closest to the school as measured in a direct line between the home address and the school.

### How the initial allocation of places was made for this school:

**Category A** – Children Looked After – Children who are in the care of a Local Authority or have previously been but immediately after being looked after became subject to an adoption, a child arrangement order, or special guardianship order. **0 Children** 

**Category B** - Children who live within a 1.5 mile radius of the school and for whom there will be a sibling who lives at the same address in attendance on the admission date at the school. **5 Children** 

**Category C** - Children who live outside a 1.5 mile radius of the school but it is their closest school and for whom there will be a sibling who lives at the same address in attendance on the admission date at the school. **0 Children** 

Category D - Children who live closest to the school as measured in a direct line from the address point of the school. 10 Children. The furthest direct line distance between the preferred school and the home address offered in this category was 3.646 miles.

1 child has been initially been refused a place at Marksbury C of E Primary School. (All other preferences originally considered have qualified for another school as a higher preference)

## Position as at 22 May 2025 following the initial allocations on 16 April 2025

Following the initial allocations on 16 April 2025, 1 of the places originally offered has become available.

1 parent originally refused a place has lodged an appeal; 1 late application was received.

These **2** children were considered for the **1** place available, and the place has been offered to:

**1** Child in Category C with the furthest direct line distance offered in this category being 2.492 miles.
