### ALLOCATIONS SHEET FOR HAYESFIELD GIRLS' SCHOOL - PLACES AVAILABLE

Applications for all schools have been considered under an equal preference system which means that all preferences (1st, 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup> & 5<sup>th</sup>) for each school have been considered equally for places under the school's published admissions criteria. If there were any cases where more than one of the school preferences named on the application form could have been met only the highest preference school has been allocated by the Local Authority.

A total of **430** applications were originally received for Hayesfield Girls' School which has a published Admission Number of **224**. The Governors/Academy Trust have agreed to work to a higher admission number of **236** for Sept 2025. As the school was oversubscribed, following any offers of places to children with an Education, Health and Care Plan, applications have been considered by the Governors/Academy Trust and places have been allocated in accordance with the school's published admissions criteria stated in the booklet 'A Secondary School for Your Child' and which are listed below in priority order.

**5 places have been offered to children with an Education, Health and Care Plan** where the school has been named in their plan. These children are included within the Admission Number for the school.

The initial allocation of places on 03 March 2025 was made on behalf of the Governors/Academy Trust of Hayesfield Girls' School to:

**Category 1** - Looked after Children or a child who was previously looked after but immediately after being looked after became subject to an adoption, child arrangement or special guardianship order. **4 Children**

**Category 2** - Siblings of students attending the School at the time the application is received. **34 Children**

**Category 3** - Children of staff at the school who have a contract of employment with the School in either or both of the following circumstances a) where the member of staff has been employed by the School for two or more years at the time at which the application is made and b) where the member of staff has been recruited to fill a skill-shortage area. **4 Children**

**Category 4** - Up to 10 places to be allocated to children who demonstrate an aptitude for sport and up to 10 places will be allocated to children who demonstrate an aptitude for music (as outlined on page 48 of the Handbook). **20 Children**

**Category 5** - Places will then be allocated to the inner and outer catchment areas as follows:

(a) 80% of the remaining places have been allocated to children living within the Bath City Boundary. **135 Children. The furthest direct line distance offered in this category was 1.726 miles.**

(b) 20% of remaining places have been allocated to girls living beyond the Bath City Boundary. **34 Children. The furthest direct line distance offered in this category was 5.733 miles.**

**52 children in total have initially been refused a place at Hayesfield Girls School.** (All other preferences originally considered have qualified for another school as a higher preference)

**Please Note** If you decide to lodge a formal appeal for a place at this particular school your initial notification of intent to appeal should be sent to your home local authority by **17 March 2025** and your letter of appeal to the Clerk to Appeals Panel, Hayesfield Girls' School, Upper Oldfield Park, Bath, BA2 3LA by no later than **31 March 2025**.

**Position as at 6 May 2025 following the initial allocations on 03 March 2025**

**26 of the places originally offered on 03 March 2025 have become available.**

16 parents originally refused a place have lodged an appeal, 18 parents opted to go on the waiting list only and 17 late applications were received.

All these children were considered for the 26 places available, and the places have been offered to:

**1** child under category 1

**2** children under category 2

**2** children under category 4

**14** children under category 5a **with the furthest direct line distance being 1.977 miles**

**7** children under category 5b **with the furthest direct line distance being 6.564 miles.**

**If being refused a place as a late applicant and** if you decide to lodge a formal appeal for a place at this particular school your initial notification of intent to appeal should be sent to your home local authority by **20 May 2025** and your letter of appeal to the Clerk to Appeals Panel, Hayesfield Girls' School, Upper Oldfield Park, Bath, BA2 3LA by no later than **4 June 2025**.
