



## **RECEPTION ADMISSIONS - SEPTEMBER 2025**

### **INITIAL ALLOCATION STATEMENT FOR OLDFIELD PARK INFANTS SCHOOL**

#### **PLACES AVAILABLE: 60**

As Oldfield Park Infant School was oversubscribed it was necessary to use the Academy Trust's admissions criteria, as published in 'A Primary School for Your Child' – 2025/26', to allocate the places available at the school. Applications for all schools are considered under an equal preference system which means that all preferences (1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup>) for each school are considered equally. If there are any cases where more than one of the school preferences named on the application form could have been met only the highest preference school has been allocated.

A total of **135 preferences** were originally received for Oldfield Park Infant School which has an Admission Number of **60**.

#### **How the initial allocation of places was made for this school:**

**0 places have been held for a child with an Education, Health and Care Plan where the school is being consulted for their plan.**

**Category A** - Looked after child or previously looked after child. **0 Children**

**Category B** - (The 2 categories in this criterion will be given equal consideration). **22 Children**

- Children who live within a 1.5 mile radius\* of the school and for whom there will be a sibling in attendance on the admissions date at the preferred school.
- Children who live outside a 1.5 mile radius\* of the school but it is their closest school and for whom there will be a sibling in attendance on the admissions date at the preferred school.

**Category C** - Children who are closest to the midpoint\* as measured in a direct line. **38 Children** The furthest direct line distance between the midpoint and the home address offered in this category was **6.651 miles**.

\*For allocation purposes for Oldfield Park Infant and Oldfield Park Juniors Schools a midpoint between these schools is used to determine distance and this is at 29 Maybrick Rd, Bath, BA2 3PU.

**3 children have initially been refused a place at Oldfield Park Infant School.** (All other preferences originally considered have qualified for another school as a higher preference)

#### **CLASS SIZE PREJUDICE APPEALS – Effects of Infant Class Size Legislation:**

Appeals for Oldfield Park Infant School will be heard on the basis of Infant Class Size Prejudice as the school will organise with two Reception classes each containing 30 pupils with one full-time qualified teacher (or the equivalent of) in each class.

**Position as at 22 May 2025 following the initial allocations on 16th April 2025**

Following the initial allocations on 16 April 2025, **1** of the places originally offered has become available.

**1** parent originally refused a place opted to appeal, **1** opted to go on the waiting list only and **3** late applications were received.

These **5** children were considered for the **1** place available, and the place has been offered to:

**1** Child under Category C - The furthest direct line distance between the midpoint and the home address offered in this category was **0.480** miles.
