**(VARIOUS ROADS, NORTH WEST OUTER AREA, BATH) (PROHIBITION AND RESTRICTION OF PARKING AND LOADING) (NO STOPPING ON ENTRANCE MARKINGS) (AUTHORISED AND DESIGNATED PARKING PLACES)**  
**(VARIATION No 1) (ORDER 202-)**

NOTICE is given that the Bath and North East Somerset Council proposes to make an order under provisions contained in the Road Traffic Regulation Act 1984, the effect of which will introduce the following variations to restrictions in **North West Outer Bath area**:-

1. Introduce No Parking At Any Time in lengths of Kennington Road, Foxcombe Road, Park Road and Warwick Road, Bath.
2. Introduce Permit Holder and 1 Hour Limited Waiting, operating between 8am – 6pm in lengths of Kennington Road, Foxcombe Road and Park Road, Bath.
3. Introduce Permit Holder and 2 Hours Limited Waiting, operating between 8am – 6pm in lengths of Warwick Road, Bath.
4. Introduce Permit Holder and 3 Hours Limited Waiting, operating between 8am – 6pm in lengths of Kennington Road and Park Road, Bath.
5. Introduce 1 Hour Limited Waiting, operating between 8am – 6pm in lengths of Chelsea Road, Bath.
6. Introduce No Waiting / No Loading At Any Time in lengths of Chelsea Road, Bath.
