1. STATEMENT

For the purpose of this report, in January 2016, the Divisional Director Environmental Services delegated the power to make, amend or revoke Notices or any Orders to the Group Manager, Highways and Traffic.

2. **LEGAL AUTHORITY**

This proposal is made in accordance with the Road Traffic Regulation Act 1984, which under Section 23 & 1 provides, generally, for Orders to be made for the following reasons, and in the case of this report specifically for the reason(s) shown with an "x" in the right hand column:

(a)	for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, or	Х
(b)	for preventing damage to the road or to any building on or near the road, or	
(c)	for facilitating the passage on the road or any other road of any class of traffic (including pedestrians), or	Х
(d)	for preventing the use of the road by vehicular traffic of a kind which, or its use by vehicular traffic in a manner which, is unsuitable having regard to the existing character of the road or adjoining property, or	
(e)	(without prejudice to the generality of paragraph (d) above) for preserving the character of the road in a case where it is specially suitable for use by persons on horseback or on foot, or

3. BACKGROUND

As part of a Section 278 Agreement associated with the development of a new primary school, care home, sheltered accommodation, residential dwellings and associated highway infrastructure and public facilities adjacent to Silver Street, Midsomer Norton, it is proposed to introduce a traffic signal controlled 'toucan' pedestrian and cycling crossing.

It is also proposed to introduce an enforceable 'school keep clear' road marking adjacent to the new primary school. The restriction prohibits parking and stopping on the marking.

4. <u>ISSUES</u>

To encourage parents and their children to walk, cycle and scoot to the new primary school, the highway infrastructure associated with the site includes new footways and cycle paths, so it is appropriate that a formal crossing facility is provided to assist pedestrians and cyclists to cross Silver Street, which is a busy 'B' classified road.

An enforceable 'school keep clear' road marking is considered appropriate to prevent parents and visitors from parking directly adjacent to the new primary school during school hours. It is proposed, therefore that the 'school keep clear' marking will be operational from 8am – 6pm, Monday to Friday.

5. SOURCE OF FINANCE

The proposed traffic signal controlled 'toucan' pedestrian crossing and 'school keep clear' is being funded by the developer.

6. CONSULTATION REQUIREMENT

The proposal requires informal consultation with the Chief Constable, Ward Members and the Cabinet Members for Transport.
