#### 1. DELEGATION

#### 2. <u>LEGAL AUTHORITY</u>

This proposal is made in accordance with the Road Traffic Regulation Act 1984, which under Section 1 provides, generally, for Orders to be made for the following reasons, and in the case of this report specifically for the reason(s) shown below:

#### 3. PROPOSAL

To implement various parking / waiting restrictions around the Keynsham and Saltford area.

#### 4. BACKGROUND

A number of proposals for: No Parking At Any Time restrictions, School Keep Clear markings, No Waiting / No Loading At Any Time, and Limited Waiting at various locations around the Keynsham and Saltford area were submitted to the Council by local residents, Ward Members and the Bath & North East Somerset Councils Traffic Management and Transport Planning Engineers. The reason behind these requests was to improve visibility and access for emergency and refuse vehicles, to allow for the safe passage and re-passage of vehicles and to provide limited on-street parking provision.

#### 5. <u>SOURCE OF FINANCE</u>

This proposal is being funded by the capital Parking budget, project code TC8302.

#### 6. INFORMAL CONSULTATION REQUIREMENT

Informal consultation was carried out with the Chief Constable, Ward Members, and the Cabinet Member for Transport.

The responses to the informal consultation can be found in TRO report number 3.

#### 7. <u>OBJECTIONS / COMMENTS RECEIVED (following the public</u> advertisement of the proposal(s)

The objection / comments received have been summarised below with the technical responses in italics underneath each one. **Appendix 1** attached to this report includes the full responses received during the 21-day public consultation.

#### Plan 3 – Maple Walk, Keynsham (No Parking At Any Time)

## Objections – 9 (including a petition with 32 names), Support – 0, Support in part - 0

#### **Objection main points raised:**

- 1) Loss of on-street parking for local residents.
- 2) Residents having to park on the busy main road.

3) No spaces for elderly residents or visitors.

4) Residents with young children having to load kids on busy main road.

5) Residents parking on the main road means they cannot keep an eye on their vehicles.

6) There is no evidence of poor visibility or vehicles approaching at high speed.

7) There have been no accidents, or damage only accidents recorded on Maple Walk.

8) The costs involved do not warrant any benefit.

Response: Due to the objections raised above by local residents and the comments received below from the local Ward Member Cllr Alan Hale in support of these objections, it is the recommendation of this report that the proposed restrictions on Maple Walk, Keynsham are removed from this Order and not implemented on-site.

## <u>Plan 7 – Temple Street, Keynsham (No Parking At Any Time / No Loading At Any Time / Limited Waiting)</u>

Objections – 1, Support – 0, Support in part - 0

#### Objection:

I am a resident of South Block Riverside on Temple Street Keynsham. I just parked my car opposite the building in Carpenters Road and noticed a sign attached to the lamp post. It stated notice given to make Temple Street a no parking area. I wholeheartedly reject this proposal. I would never have bought my flat if I had known this was likely to happen. Having parking directly outside the building is handy for loading/unloading shopping etc and my parents are not extremely mobile so having the opportunity for them to park close to the building when visiting is helpful. Moving into the building would've been a nightmare had I not been able to park outside. Temple Street is not just a place of business, people live here and pay council tax so please think about our needs rather than just the needs of visitors you want to attract.

Response: The proposed No Parking At Any Time restrictions only cover two small sections of Temple Street removing 4 cars length of parking, with the majority of the current on-street parking being retained for local residents and visitors to the high street. Therefore, as only one objection was received to this proposal it is the recommendation of this report that the proposed restrictions are sealed within this Order as advertised and implemented on-site.
