**Bath and North East Somerset Council (City of Bath Definitive Map and Statement
Modification Order) (No. 10 – Walcot) 2014**

This Order is made by Bath and North East Somerset Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ('the Act') because it appears to that authority that the City of Bath Definitive Map and Statement require modification in consequence of the occurrence of:

- (i) an event specified in section 53(3)(c)(i), namely, that rights of way which are not shown on the map and statement subsist or are reasonably alleged to subsist over land in the area to which the maps relate, being rights of way such that the land over which the rights subsist are public paths; and
- (ii) an event specified in section 53(3)(c)(iii) of the Act, namely, that any particulars contained in the map and statement require modification.

The authority has consulted with every local authority whose area includes the land to which the order relates. The Bath and North East Somerset Council hereby order that:

1. For the purposes of this order the relevant date is 12th December 2013.
2. The City of Bath Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the maps attached to the Order.
3. This order shall take effect on the date it is confirmed and may be cited as the Bath and North East Somerset Council (City of Bath Definitive Map and Statement Modification Order) (No. 10 – Walcot) 2014.

BC55/17

A footpath in Bath and North East Somerset running from point A at Grid Reference ST 7525 6588 on Thomas Street and continuing for a distance of approximately 38 metres in a north-north-easterly direction to point B at Grid Reference ST 7525 6591 where it finishes on Seymour Road and shown by a broken black line with short intervals marked A-B on the map numbered Part 2 annexed to this order, the number of this footpath to be known as BC55/17.

BC55/18

A footpath in Bath and North East Somerset running from point A at Grid Reference ST 7521 6586 on public footpath AQ163 and continuing for a distance of approximately 12 metres in a north-easterly direction to point B at Grid Reference ST 7521 6587 where the direction changes to north-westerly. The footpath continues for a distance of approximately 4 metres to point C at Grid Reference ST 7521 6587 where the direction changes to north-easterly. The footpath continues for a distance of approximately 26 metres to point D at Grid Reference ST 7523 6589 where the direction changes to south-easterly and steps start. The footpath continues down the steps for a distance of approximately 14 metres to where it finishes on Thomas Street at point E at Grid Reference ST 7524 6588 and shown by a broken black line with short intervals marked A-B-C-D-E on the map numbered Part 3 annexed to this order, the number of this footpath to be known as BC55/18.

BC55/19

A footpath in Bath and North East Somerset running from staggered barriers at point A at Grid Reference ST 7538 6561 on Bathwick Street and continuing in a northerly direction for a distance of approximately 26 metres to a staggered barrier at point B

at Grid Reference ST 7538 6563. The direction changes to north-easterly and the footpath continues for a distance of approximately 34 metres to point C at Grid Reference ST 7541 6565 where it finishes on Forester Avenue and shown by a broken black line with short intervals marked A-B-C on the map numbered Part 4 annexed to this order, the number of this footpath to be known as BC55/19.

BC56/25

A footpath in Bath and North East Somerset running from point A at Grid Reference ST 7542 6653 on Fairfield Park Road and continuing for a distance of approximately 24 metres in a north-easterly direction to steps at point B at Grid Reference ST 7545 6653. The footpath continues down the steps for a distance of approximately 2 metres to point C at Grid Reference ST 7545 6653 where the steps end. The footpath continues for a distance of approximately 122 metres to where it finishes on public footpath BC56/13 at point D at Grid Reference ST 7555 6659 and shown by a broken black line with short intervals marked A-B-C-D on the map numbered Part 5 annexed to this order, the number of this footpath to be known as BC56/25.

BC56/26

A footpath in Bath and North East Somerset running from point A at Grid Reference ST 7556 6649 on Hampton View and continuing in a northerly direction for a distance of approximately 35 metres to point B at Grid Reference ST 7555 6652 where steps start. The footpath continues down the steps for a distance of approximately 7 metres to where it finishes on Midsummer Buildings at point C at Grid Reference ST 7556 6653 and shown by a broken black line with short intervals marked A-B-C on the map numbered Part 6 annexed to this order, the number of this footpath to be known as BC56/26.

BC56/27

A footpath in Bath and North East Somerset running from a bollard at point A at Grid Reference ST 7523 6625 on Summerfield Road and continuing down steps for a distance of approximately 3 metres in a southerly direction to point B at Grid Reference ST 7523 6624 where the direction changes to east-north-easterly. The footpath continues for a distance of approximately 30 metres to where the direction changes to north-easterly at point C at Grid Reference ST 7526 6625. The footpath continues for a distance of approximately 17 metres to where steps start at point D at Grid Reference ST 7526 6627. The steps continue for a distance of approximately 13 metres to where the direction changes at point E at Grid Reference ST 7527 6628. The footpath continues for a distance of approximately 12 metres to where the steps end at point F at Grid Reference ST 7528 6628. The footpath continues for a distance of approximately 66 metres to where it finishes on Claremont Walk at point G at Grid Reference ST 7534 6630 and shown by a broken black line with short intervals marked A-B-C-D-E-F-G on the map numbered Part 7 annexed to this order, the number of this footpath to be known as BC56/27.

BC56/28

A footpath in Bath and North East Somerset running from point A at Grid Reference ST 7529 6621 on Rivers Road and continuing in a north-easterly direction for a distance of approximately 18 metres to where it finishes on public footpath AQ160 (Donkey Lane) at point B at Grid Reference ST 7530 6623 and shown by a broken

black line with short intervals marked A-B on the map numbered Part 8 annexed to this order, the number of this footpath to be known as BC56/28.

BC56/29

A footpath in Bath and North East Somerset running from point A at Grid Reference ST 7541 6621 on Camden Road and continuing down steps for a distance of approximately 8 metres in a south-westerly direction to point B at Grid Reference ST 7541 6620 where the direction changes to south-easterly. The footpath continues for a distance of approximately 5 metres to point C at Grid Reference ST 7541 6620 where the steps end. The footpath continues for a distance of approximately 18 metres to steps at point D at Grid Reference ST 7542 6619 and continues down the steps for a distance of approximately 5 metres to where it finishes on Arundel Road at point E at Grid Reference ST 7543 6619 and shown by a broken black line with short intervals marked A-B-C-D-E on the map numbered Part 9 annexed to this order, the number of this footpath to be known as BC56/29.

BC56/30

A footpath in Bath and North East Somerset running from point A at Grid Reference ST 7519 6614 on Rivers Road and continuing in a north-westerly direction for a distance of approximately 11 metres to point B at Grid Reference ST 7518 6615 where steps start. The footpath continues up the steps for a distance of approximately 17 metres to where the direction changes to north-easterly at point C at Grid Reference ST 7517 6616. The footpath continues up the steps for a distance of approximately 3 metres to where the steps end at point D at Grid Reference ST 7517 6616. The footpath continues for a distance of approximately 75 metres to where steps start at point E at Grid Reference ST 7521 6622. The footpath continues for a distance of approximately 28 metres up the steps to where it finishes on public footpath BC56/27 at point F at Grid Reference ST 7523 6624 and shown by a broken black line with short intervals marked A-B-C-D-E-F on the map numbered Part 10 annexed to this order, the number of this footpath to be known as BC56/30.

BC56/31

A footpath in Bath and North East Somerset running from point A at Grid Reference ST 7561 6606 on Hanover Street and continuing for a distance of approximately 1 metre in a north-westerly direction to point B at Grid Reference ST 7561 6606 where steps start. The footpath continues for a distance of approximately 3 metres to point C at Grid Reference ST 7561 6607 where the steps end. The footpath continues for a distance of approximately 1 metre to point D at Grid Reference ST 7561 6607 where the direction changes to north-north-easterly. The footpath continues for a distance of approximately 20 metres to point E at Grid Reference ST 7561 6609 where steps begin. The footpath continues for a distance of approximately 2 metres to point F at Grid Reference ST 7561 6609 where the steps end. The footpath continues for a distance of approximately 1 metre to point G at Grid Reference ST 7561 6609 where the direction changes to north-westerly. The footpath continues for a distance of approximately 2 metres to point H at Grid Reference ST 7561 6609 where it finishes on Kensington Gardens and shown by a broken black line with short intervals marked A-B-C-D-E-F-G-H on the map numbered Part 11 annexed to this order, the number of this footpath to be known as BC56/31.

BC56/32

A footpath in Bath and North East Somerset running from a bollard at point A at Grid Reference ST 7543 6607 on Highbury Place and continuing for a distance of approximately 37 metres in an east-south-easterly direction to point B at Grid Reference ST 7546 6605 where steps start. The footpath continues down the steps for a distance of approximately 4 metres to point C at Grid Reference ST 7546 6605 where it finishes on Snow Hill and shown by a broken black line with short intervals marked A-B-C on the map numbered Part 12 annexed to this order, the number of this footpath to be known as BC56/32.

BC56/33

A footpath in Bath and North East Somerset running from point A at Grid Reference ST 7555 6603 on Brunswick Street and continuing for a distance of approximately 2 metres in a northerly direction to point B at Grid Reference ST 7555 6604 where steps start. The footpath continues up the steps for a distance of approximately 17 metres to where the steps end at point C at Grid Reference ST 7555 6605. The footpath continues for a distance of approximately 2 metres to point D at Grid Reference ST 7555 6606 where it finishes on Kensington Gardens and shown by a broken black line with short intervals marked A-B-C-D on the map numbered Part 13 annexed to this order, the number of this footpath to be known as BC56/33.

BC56/34

A footpath in Bath and North East Somerset running down three steps from point A at Grid Reference ST 7546 6601 on Snow Hill and continuing in a south-easterly direction down three flights of steps for a distance of approximately 52 metres to point B at Grid Reference ST 7549 6597 where it continues for a distance of approximately 25 metres to point C at Grid Reference ST 7551 6595. The footpath continues down steps for a distance of approximately 6 metres to point D at Grid Reference ST 7551 6594 where it finishes on Snow Hill and shown by a broken black line with short intervals marked A-B-C-D on the map numbered Part 14 annexed to this order, the number of this footpath to be known as BC56/34.

BC56/35

A footpath in Bath and North East Somerset running from point A at Grid Reference ST 7575 6602 on Kensington Place and continuing in a south-south-easterly direction for a distance of approximately 97 metres to point B at Grid Reference ST 7580 6593 where the direction changes to south-easterly. The footpath continues for a distance of approximately 9 metres to point C at Grid Reference ST 7581 6593 where it changes direction to south-south-westerly. The footpath continues for a distance of approximately 19 metres to point D at Grid Reference ST 7581 6592 where the direction changes to west-south-westerly. The footpath continues for a distance of approximately 54 metres to point E at Grid Reference ST 7575 6590 where the direction changes to southerly. The footpath continues for a distance of approximately 73 metres to point F at Grid Reference ST 7577 6583 where the direction changes to west-south-westerly. The footpath continues for a distance of approximately 15 metres to metal posts at point G at Grid Reference ST 7576 6582. The footpath continues for a distance of approximately 23 metres to point H at Grid Reference ST 7574 6581 where the direction changes to easterly. The footpath continues for a distance of approximately 62 metres to point I at Grid Reference ST 7580 6581 where the direction changes to north-easterly. The

footpath continues for a distance of approximately 443 metres to point J at Grid Reference ST 7620 6598 where the direction changes to north-north-easterly. The footpath continues for a distance of approximately 128 metres to point K Grid Reference ST 7623 6610 where steps start.
