

WILDLIFE AND COUNTRYSIDE ACT 1981**CITY OF BATH DEFINITIVE MAP AND STATEMENT****Bath and North East Somerset Council (City of Bath Definitive Map and Statement Modification Order) (No. 6 - Kingsmead) 2007**

This Order is made by Bath and North East Somerset Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ('the Act') because it appears to that authority that the City of Bath Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i), namely, that rights of way which are not shown on the map and statement subsist or are reasonably alleged to subsist over land in the area to which the maps relate, being rights of way to which this Part applies

The authority has consulted with every local authority whose area includes the land to which the order relates. The Bath and North East Somerset Council hereby order that:

1. For the purposes of this order the relevant date is 9th October 2007.
2. The City of Bath Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the maps attached to the Order.
3. This order shall take effect on the date it is confirmed and may be cited as the Bath and North East Somerset Council (City of Bath Definitive Map and Statement Modification Order) (No. 6 - Kingsmead) 2007.

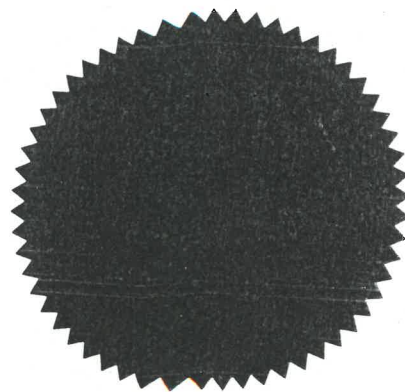

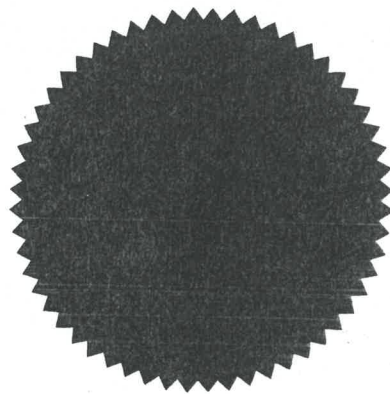

The footpath continues for a distance of approximately 8m to where it finishes on Badminton Gardens at point C at Grid Reference ST 7345 6558 and shown by a broken black line with short intervals marked A-B-C on the map numbered AQ164a annexed to this order, the number of this footpath to be known as BC35/5.

AQ164b

A footpath in Bath and North East Somerset running from point A at Grid Reference ST 7345 6558 on footpath AQ164a and continuing in an easterly direction for a distance of approximately 56m to point B at Grid Reference ST 7350 6558 where the direction changes to southerly. The footpath continues for a distance of approximately 4m to where it finishes on Oakfield Close at point C at Grid Reference ST 7350 6558 and shown by a broken black line with short intervals marked A-B-C on the map numbered AQ164b annexed to this order, the number of this footpath to be known as BC35/6.

AQ349b

A footpath in Bath and North East Somerset running from bollards at point A at Grid Reference ST 7457 6532 on Brock Street and continuing in a southerly direction for a distance of approximately 54m to point B at Grid Reference ST 7455 6527 where the direction changes to south-easterly. The footpath continues for a distance of approximately 280m to steps and continues down the steps for a distance of approximately 4m to where it finishes on Queen's Parade Place at point C at Grid Reference ST 7474 6509 and shown by a broken black line with short intervals marked A-B-C on the map numbered AQ349b annexed to this order, the number of this footpath to be known as BC45/16.

AQ350

A restricted byway in Bath and North East Somerset running from point A at Grid Reference ST 7410 6496 on Victoria Bridge Road and continuing across Victoria Bridge in a north-north-easterly direction for a distance of approximately 85m to bollards. The restricted byway continues for a distance of approximately 2m to where it finishes on Victoria Bridge Road at point B at Grid Reference ST 7413 6504 and shown by a broken black line with short

intervals marked A-B on the map numbered AQ350 annexed to this order, the number of this footpath to be known as BC44/3.

AQ415

A footpath in Bath and North East Somerset running from bollards at point A on Monmouth Street at Grid Reference ST 7481 6480 and continuing in a north-easterly direction for a distance of approximately 49m to where it finishes on Saw Close at point B at Grid Reference ST 7486 6482 and shown by a broken black line with short intervals marked A-B on the map numbered AQ415 annexed to this order, the number of this footpath to be known as BC44/12.

BQ19

A footpath in Bath and North East Somerset running from staggered barriers at point A on Audley Grove at Grid Reference ST 7323 6554 and continuing in a northerly direction for a distance of approximately 62m to where it finishes on Gainsborough Gardens at point B at Grid Reference ST 7323 6561 and shown by a broken black line with short intervals marked A-B on the map numbered BQ19 annexed to this order, the number of this footpath to be known as BC35/4.

CQ2

A footpath in Bath and North East Somerset running from point A on Upper Bristol Road at Grid Reference ST 7352 6512 and continuing in a south-easterly direction for a distance of approximately 55m to where it finishes on the towpath at point B at Grid Reference ST 7354 6507 and shown by a broken black line with short intervals marked A-B on the map numbered CQ2 annexed to this order, the number of this footpath to be known as BC35/9.

K2

A footpath in Bath and North East Somerset running from point A on Locksbrook Road at Grid Reference ST 7339 6507 and continuing in a south-easterly direction for a distance of approximately 33m to point B at Grid Reference ST 7341 6504 where the direction changes to east-south-easterly. The footpath continues for a distance of approximately 6m to a squeeze stile at point C at Grid Reference ST 7342 6504. The footpath continues for a distance of approximately 72m to where it finishes on the towpath at point D at Grid Reference ST 7349 6504 and shown by a broken black line with short intervals marked A-D on the map numbered K2 annexed to this order, the number of this footpath to be known as BC35/7.

K3

A footpath in Bath and North East Somerset running from point A on footpath K2 at Grid Reference ST 7342 6504 and continuing in a south-south-easterly direction for a distance of approximately 64m to where it finishes on the towpath at point B at Grid Reference ST 7344 6498 and shown by a broken black line with short intervals marked A-B on the map numbered K3 annexed to this order, the number of this footpath to be known as BC35/8.

K39

A footpath in Bath and North East Somerset running from a bollard at point A on Nelson Lane at Grid Reference ST 7428 6501 and continuing in a northerly direction for a distance of approximately 20m to a bollard on Upper Bristol Road at point B at Grid Reference ST 7428 6503 where it finishes and shown by a broken black line with short intervals marked A-

B on the map numbered K39 annexed to this order, the number of this footpath to be known as BC45/15.

K41

A footpath in Bath and North East Somerset running from a kissing gate at point A on the towpath at Grid Reference ST 7429 6488 and continuing in a north-easterly direction for a distance of approximately 7m to point B at Grid Reference ST 7430 6489 where the direction changes to south-easterly. The footpath continues for a distance of approximately 26m to point C at Grid Reference ST 7432 6487 where the direction changes to east-north-easterly. The footpath continues for a distance of approximately 7m to where it finishes on Norfolk Crescent at point D at Grid Reference ST 7433 6487 and shown by a broken black line with short intervals marked A-D on the map numbered K41 annexed to this order, the number of this footpath to be known as BC44/4.

K42

A footpath in Bath and North East Somerset running from point A on the towpath at Grid Reference ST 7438 6478 and continuing in a north-easterly direction for a distance of approximately 9m to steps at point B at Grid Reference ST 7439 6479. The footpath continues up the steps for a distance of approximately 3m to where it finishes on Norfolk Buildings at point C at Grid Reference ST 7439 6479 and shown by a broken black line with short intervals marked A-C on the map numbered K42 annexed to this order, the number of this footpath to be known as BC44/5.

K45

A footpath in Bath and North East Somerset running from point A on the towpath at Grid Reference ST 7412 6502 and continuing in a north-north-easterly direction for a distance of approximately 10m to steps at point B at Grid Reference ST 7412 6503. The footpath changes direction and continues up the steps in an east-south-easterly direction for a distance of approximately 6m to where it finishes on Victoria Bridge at point C at Grid Reference ST 7413 6503 and shown by a broken black line with short intervals marked A-C on the map numbered K45 annexed to this order, the number of this footpath to be known as BC45/14.

K47

A footpath in Bath and North East Somerset running from point A on Green Park Road at Grid Reference ST 7463 6458 and continuing in a north-easterly direction for a distance of approximately 1m to steps. The footpath continues down the steps for a distance of approximately 1m. It continues for a distance of approximately 1m to where it finishes on Kingsmead West at point B at Grid Reference ST 7463 6459 and shown by a broken black line with short intervals marked A-B on the map numbered K47 annexed to this order, the number of this footpath to be known as BC44/7.

K48a

A footpath in Bath and North East Somerset running from point A on footpath K48c at Grid Reference ST 7472 6462 and continuing in an easterly direction for a distance of approximately 11m to point B at Grid Reference ST 7473 6461 where the direction changes to northerly. The footpath continues for a distance of approximately 41m to where it finishes on Kingsmead North at point C at Grid Reference ST 7473 6465 and shown by a broken black line with short intervals marked A-C on the map numbered K48a annexed to this order, the number of this footpath to be known as BC44/10.

K48b

A footpath in Bath and North East Somerset running from point A on footpath K48c at Grid Reference ST 7472 6462 and continuing in a northerly direction for a distance of approximately 9m to point B at Grid Reference ST 7472 6463 where the direction changes to east-north-easterly. 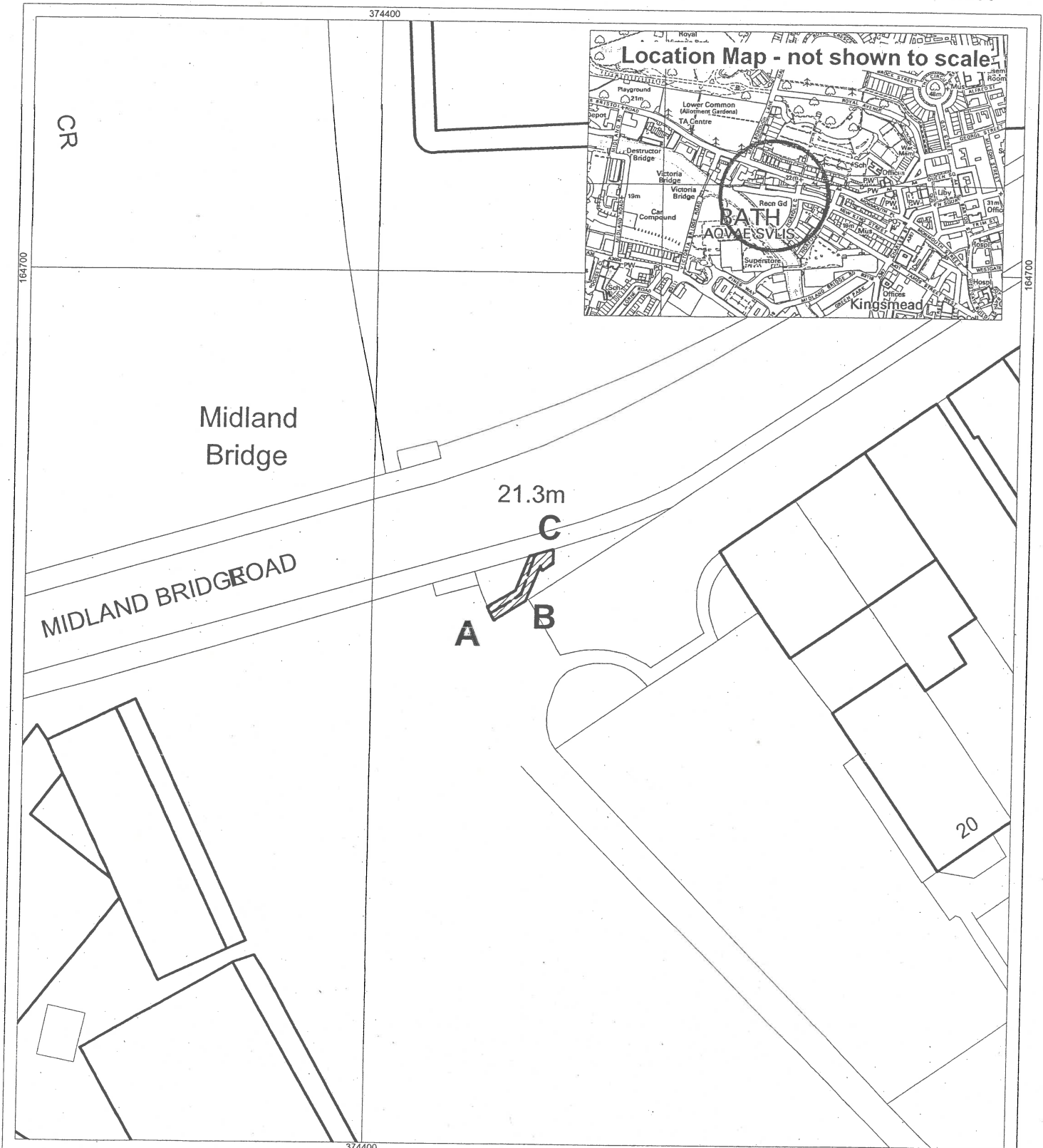
