The enforcement of these restrictions will benefit road users most affected when drivers contravene traffic restrictions that are implemented to improve road safety.	Drivers and riders of motor vehicles who contravene one of the enforced traffic restrictions will be liable to pay a penalty charge notice.  The UK Parliament is actively addressing the disability pay gap through consultations and proposed legislation, notably within the Equality (Race and Disability) Bill. This bill includes provisions for mandatory disability and ethnicity pay gap reporting for larger employers, aiming to create a more equal society and support economic growth. The consultation process seeks input on how to gather meaningful data and ensure it's used effectively by employers to address the disparities.  This indicates that disabled people experience pay discrimination at work, therefore disabled people may be disproportionately impacted by the issuing of penalties for contravening traffic restrictions.  Motorists who do not contravene traffic restrictions will not be liable to pay a penalty.  Any unintended impacts impact should be considered against the needs of managing our highway network to ensure strategic objectives are met.	No known impacts
