(VARIOUS ROADS, COMPTON DANDO, HINTON CHARTERHOUSE, PENSFORD, TIMSBURY & WHITCHURCH) (20 M.P.H. SPEED LIMIT) (30 M.P.H. SPEED LIMIT) (VARIATION NO.1) ORDER 2023

The Bath and North East Somerset Council (“the Council”) in exercise of its powers under sections 1(1), 2(1) to (3) of the Road Traffic Regulation Act 1984 (“the 1984 Act”) and of all other enabling powers, after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the 1984 Act, makes the following Order: -

1. This Order comes into operation on the **** and may be cited as the Bath and North East Somerset Council (Various Roads, Compton Dando, Hinton Charterhouse, Pensford, Timsbury and Whitchurch) (20 M.P.H. Speed Limit) (30 M.P.H. Speed Limit) (Variation No.1) Order 2023.
2. No person shall drive any motor vehicle at a speed exceeding 20 miles per hour on those lengths of roads described in Schedule 1 to this order.
3. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on those lengths of roads described in Schedule 2 to this order.
4. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011, when used in accordance with regulation 3(5) of those Regulations.

VARIATION OF EXISTING ORDER

a. The Bath and North East Somerset Council (Various Roads, Compton Dando, Hinton Charterhouse, Pensford, Timsbury and Whitchurch) (20 M.P.H speed limit) (30 M.P.H. Speed Limit) Order 2016 is varied and has effect as though schedule 1 of that Order includes:

SCHEDULE 1

20 M.P.H. Speed Limit

Hayeswood Road

From its junction with North Road for a distance of 55 metres in a westerly direction.

Bloomfield Road

From its junction with North Road for a distance of 70 meters in a northerly direction

b. The Bath and North East Somerset Council (Various Roads, Compton Dando, Hinton Charterhouse, Pensford, Timsbury and Whitchurch) (20 M.P.H speed limit) (30 M.P.H. Speed Limit) Order 2016 is varied and has effect as though schedule 1 of that Order changes from:

Lippiatt Lane	From its junction with North Road for a distance of 364 meters in a northerly direction.
North Road	From its junction with Hook to a point 70 meters east of its junction with Bloomfield Road.
The Avenue	From its junction with Church Hill to a point 18 meters north west of its junction with Somerset Folly.

TO:

Lippiatt Lane	Entire length.
North Road	Entire length.
The Avenue	Entire length.

c. The Bath and North East Somerset Council (Various Roads, Compton Dando, Hinton Charterhouse, Pensford, Timsbury and Whitchurch) (20 M.P.H speed limit) (30 M.P.H. Speed Limit) Order 2016 is varied and has effect as though the following roads are removed from schedule 2 of that Order:

**SCHEDULE 2
30 M.P.H. Speed Limit**

North Road	From a point 70 meters east of its junction with Bloomfield Road for a distance of 143 meters in a westerly direction.
The Avenue	From a point 18 meters north west of its junction with Somerset Folly to its junction with North Road.
