

SPEED LIMIT – NOTICE OF INTENTION

BATH AND NORTH EAST SOMERSET COUNCIL

(25-003) (FAIR ASH, B3114 BRISTOL ROAD, STRATFORD LANE, WEST HARPTREE VILLAGE)

(20 M.P.H. SPEED LIMIT) ORDER 202*

NOTICE is given that Bath and North East Somerset Council proposes to make an order under provisions contained in the Road Traffic Regulations Act 1984, the effect of which will be that it is prohibited to drive a motor vehicle at a speed exceeding 20 miles per hour on the lengths of road as listed in Schedule 1 to this Notice.

Full details of the proposals, together with a map and a Statement of the Council's Reasons for proposing to make the order, may be inspected at the One Stop Shops at Manvers Street, Bath, The Hollies, High Street, Midsomer Norton and at the Civic Centre, Market Walk, Keynsham during normal office hours or may be requested, free of charge, by contacting by email council_connect@bathnes.gov.uk. Fair Ash, West Harptree.	That length of Fair Ash, West Harptree, which extends from its junction with the B3114 Bristol Road for approximately 136 metres in a south westerly direction.
B3114 Bristol Road, West Harptree.	That length of the B3114 Bristol Road, West Harptree which extends from its junction with the A368 The Street, West Harptree to a point approximately 100 metres north west of its junction with Stratford Lane.
Stratford Lane, West Harptree.	For its entire length.
