

BATH AND NORTH EAST SOMERSET COUNCIL

**(24-032) (BEAU STREET / STALL STREET, BATH) (PROHIBITION OF PARKING)
(PROHIBITION OF DRIVING OF MOTOR VEHICLES) (SUSPENSION OF ONE-
WAY TRAFFIC) ORDER 2025**

The Bath and North East Somerset Council (“the Council”) in exercise of its powers under sections 1, 2, 4, 32, 35, 45, 46, 49, 51, 53 and 63A of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the 1984 Act”) and of all other enabling powers, after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the 1984 Act, makes the following order:-

1. This order comes into operation on 8th May 2025 and may be cited as the Bath and North East Somerset Council (Beau Street / Stall Street, Bath) (Prohibition of Parking) (Prohibition of Driving of Motor Vehicles) (Suspension of One-Way Traffic) Order 2025
2. It is prohibited to cause or permit any motor vehicle to drive between 6pm to 10am daily on Beau Street from its junction with Stall Street, Bath.
3. The central zone parking bay shown on the map in schedule 2 to this Order on Beau Street is suspended and replaced with a No Parking / No Loading At Any Time restriction.
4. The existing one-way traffic restriction on Beau Street described within schedule 1 of Order 1557 (Various Roads, Central Area, Bath) (General Traffic Circulation) (Consolidation) (Order 2015) is revoked and replaced by the description contained within schedule 1 of this Order allowing two-way traffic on Beau Street between the junctions of Stall Street and Bilbury Lane.

Additions, Revocations and Modifications

5. Beau Street in schedule 1 of The Bath and North East Somerset Council (Various Roads, Central Area, Bath) (General Traffic Circulation) (Consolidation) (Order 2015) (as amended) is revoked and replaced with the description contained within schedule 1 in this Order.
6. The Bath and North East Somerset Council (Various Roads, Bath and North East Somerset) (Prohibition of stopping, waiting, loading and parking places) (Consolidation) Order 2024 (as amended) is varied as provided by the following plans attached to schedule 2 in this Order.
7. The plan(s) attached to this Order are hereby attached to (24-032) (Beau Street / Stall Street, Bath) (Prohibition of Parking) (Prohibition of Driving of Motor Vehicles) (Suspension of One-Way Traffic) Order 2025 and forms part of that Order.

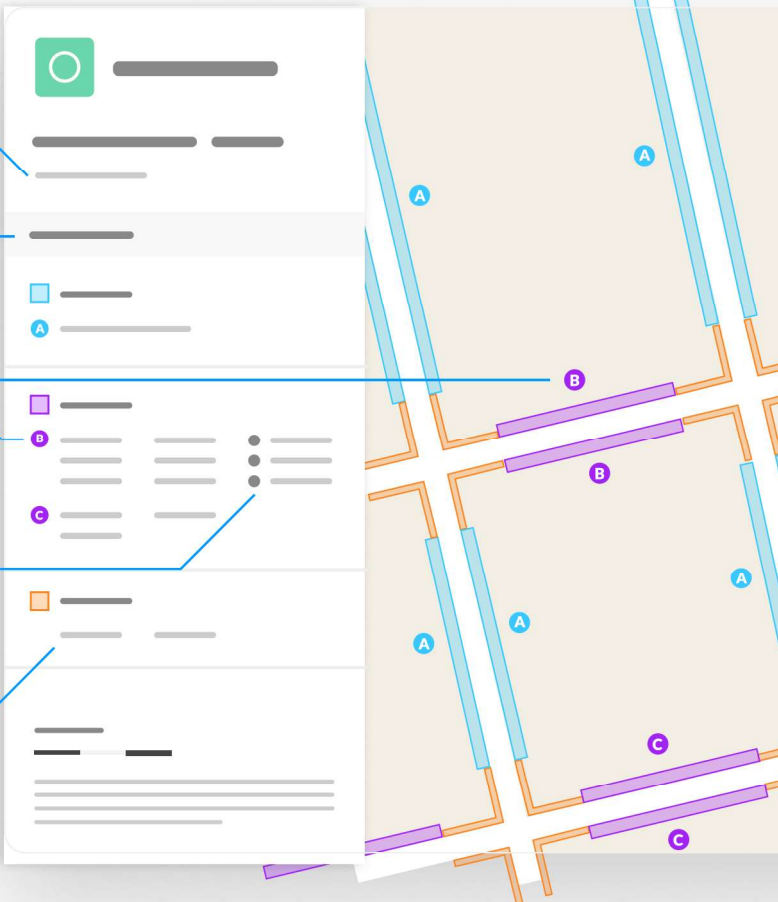
