# Public Consultation Survey: Lyme Road, Lyme Gardens and Charmouth Road area

## **Proposal for a School Street and a new one-way system**

Thank you for sharing your views on a proposal for a new School Street and a one-way system around the Lyme Road area.

These proposals are designed to create a safer, healthier and calmer environment in the Lyme Road area by managing traffic flow in a predictable, one-way direction and restricting access to most vehicles on Charmouth Road (north of the junction with Lyme Road) between 8:30 and 9:05 am and again between 2:55 and 3:40 pm during weekdays in term-time.

Vehicle exemptions will apply during the timed restrictions for essential access (e.g. emergency services, utilities, residents living on the school street).

We are also proposing three continuous crossings in the area to improve the safety of pedestrians. While these are not officially included in this Traffic Regulation Order (they would be subject to a separate legal notice in 2026) you are welcome to comment on these measures at the end of the survey. We are considering the feedback we have already received on continuous crossings from earlier engagement with the community before a final decision is made to proceed.
