1. <u>DELEGATION</u>

The delegation to be exercised in this report is contained within **Part 3**, **Section 4** of the Constitution under the **Delegation of Functions to Officers**, as follows:

Section A	The Chief Executive, Strategic Directors, Divisional Directors and Heads of Service have delegated power to take any decision falling within their area of responsibility"

For the purposes of this report, the Director of Place Management and the Head of Highways Delivery holds the delegated power to make, amend or revoke any Orders.

2. **LEGAL AUTHORITY**

This proposal is made in accordance with the Road Traffic Regulation Act 1984, which under Section 1 provides, generally, for Orders to be made for the following reasons, and in the case of this report specifically for the reason(s) shown below:

3. PROPOSAL

To implement various parking / waiting restrictions around the South West area of Bath as requested by the local Ward Members of behalf of their residents for the reasons as stated above.

Please refer to the separate Statement of Reasons document attached to this report regarding TRO 25-005.

The Council has had in mind and discharged the duty (as set out in section 122(1) of the Road Traffic Regulation Act 1984) to secure the expeditious, convenient and safe movement of vehicular and other traffic (including pedestrians) so far as practicable. It has also had regard to the factors which point in favour of imposing the following restrictions in the South West area of Bath:

- Additional Double Yellow Line restrictions on: Ambleside Road, Monksdale Road, Poplar Close, Southdown Road, Oldfield Road, Sladebrook Road, Haycombe Drive, Newton Road, How Hill, Upper Bloomfield Road, Bloomfield Drive, Roundhill Grove, Mount Road, Bellotts Road, Moorfields Road, Bloomfield Park, The Oval, Kelston View, Whimster Court, Shaws Way, Watery Lane, East Close, Hatfield Road, Clarks Way, Breachwood View, Middlewood Close, Orchid Drive, Lansdown View, King George Road, Dartmouth Avenue, St Kilda's Road, and Shophouse Road.
- The removal of a section of No Parking At Any Time in Moorfields Drive.
- No Stopping At Any Time on School Keep Clear markings on Lymore Avenue, Claude Avenue and Lymore Terrace
- Disabled parking bays on Moorland Road, Dorset Close and Highland Road.
- The extension of Zone 28 to include Claude Terrace and property number 35 Bloomfield Avenue.
- Zone 28 Permit Holder Only parking in Bellotts Road and Oldfield Road.
- 20 minute Limited Waiting bay operating Monday Saturday, 8am 4pm in High Street, Twerton.
- The reallocation of a number of properties currently within Zone 4 to Zone 5 on the

Wellsway.

- Zone 28 Permit Holder and 3 Hour Limited Waiting operating 8am 6pm on Monksdale Road, Beckhampton Road and Cynthia Road.
- 2 Hour Limited Waiting operating 8am 6pm in Dartmouth Avenue.

It has balanced the various considerations and concluded that it is appropriate to promote these proposed restriction amendments to prevent obstruction of the highway, improve visibility splays at junctions and provide additional on-street parking provision. The Council has also considered and discharged its network management duty under section 16 of the Traffic Management Act 2004. It has concluded that the proposed restrictions are consistent with that duty, having regard to its other policies and objectives.

5. IMPACT ON EQUALITIES

An Equality Impact Assessment has been undertaken in relation to proposed restrictions outlined above, which is available upon request. The Council has had due regard to the needs set out in section 149(1) of the Equality Act 2010. It considers that the proposed Order is consistent with the section 149 public sector equality duty, which it has discharged.

6. IMPACT ON HUMAN RIGHTS

The proposals are considered to have a minimal impact on human rights (such as the right to respect for private and family life and the right to peaceful enjoyment of property). However, the Council is entitled to affect these rights where it is in accordance with the law, necessary (in the interests of public safety or economic well-being, to prevent disorder and crime, to protect health, or to protect the rights and freedoms of others), in pursuit of a legitimate aim and proportionate to do so. The proposal(s) within this report are considered to be in accordance with the law, necessary, in pursuit of a legitimate aim and proportionate.

7. SOURCE OF FINANCE

This proposal is being funded by the capital Parking budget, project code TCJ0009S.

8. CONSULTATION REQUIREMENT

The proposal requires consultation with the Chief Constable, Emergency Services, Road Haulage Association, Freight Transport Association (Logistics UK), Parking Services, Waste Services, Ward Members and the Cabinet Member for Highways.

9. COMMENTS RECEIVED TO DATE

Chief Constable

Enforcement of waiting restrictions within the Bath and North east Somerset Council area rests with Bath and North East Somerset Council Parking Services.

Consideration regarding the potential displacement of existing parking, and the enforcement needs of these restrictions should be of importance. The proposals should meet the aspirations behind their introduction.

Emergency Services

Road Haulage Association

Freight Transport Association

Parking Services

I broadly support the implementation of the restrictions but there should be a recognition that additional restrictions require additional revenue support for new staff to reflect the fact that every new restriction requires a very small percentage of a staff member to enforce on a regular or semi-regular basis.

Whilst this impact may itself be small for a single scheme, the cumulative impact may have an impact for the enforcement across other locations.


Ward Members

Twerton & Whiteway:

Cllr Tim Ball – Agreed by me.

Cllr Sarah Moore – This is to confirm I am happy with the proposals for Twerton and Whiteway. Is it possible to have a plated enforceable disabled bay outside 16 Garrick Road added to these for Twerton please.

Response: Additional proposal Plan 44 for a Blue Badge Holder only parking bay on Garrick Road as below will be put forward for public consultation.



Southdown:

Cllr Paul Crossley – Thank you for this list of proposals in Southdown: Dartmouth Ave, Lyemore Ave, Claude Ave, Lymore Terr, Southdown Road, Sladebrook Road, Mount Road, Roundhill Grove, Lansdown V, King George and Shophouse. I am happy for all these proposals to go forward to consultation.

Cllr Dino Romero - No comment.

Odd Down:

Cllr Steve Hedges – No comment.

Cllr Joel Hirst - I think this all looks good.

Moorlands:

Cllr Jess David - There is one further request that I would like to support please – on Bloomfield Park please can we consult on a section of double yellow on the outside of the bend (outside no51) along the dropped kerb. The residents here are experience cars blocking their driveway. One of the residents also uses a wheelchair/ wheelchair bike and requires clear access. Based on some further discussions with residents in Bloomfield Park who are finding it difficult to leave their drives due to commuter parking, please could I request a further amendment to the TRO consultation for Bloomfield Park - and extend the double yellow lines to outside of Number 1 Bloomfield Park (just beyond the dropped kerb). I have indicated this on this attached map. I believe this will be a helpful intervention, keeping parking to one side of

the road, helping residents to access their drives and improving visibility around the bend. I have indicated this in the map below in yellow. Otherwise, I support the proposals for Moorlands Ward set out in the draft TRO.



Oldfield Park:

Cllr Ian Halsall - With regards the proposition of transferring a parking bay on the north side of Wells Road from Zone 4 to 5 (Plan 31) to offer a degree of fairness to those residents who are required to park at some distance from their homes but are unable to have any opportunity to park in the bay directly in front of their homes, I appreciate that without further increases in capacity within Zone 4 that this may place residents on the south side of Wells Road at some disadvantage.

I clearly want to support residents in my ward hence making this request on their behalf. However, I will not make any further representations on this proposal and will leave this with the Cabinet Member and Director.

I will seek to discuss potential scope for changes in the next round with the ward members for Widcombe and Lyncombe in relation to parking provision in this part of the Wellsway and Hayesfield Park prior to the next round of reviews.

I would fully support the minor alteration to Zone 28 in transferring number 35 Bloomfield Avenue from Zone 18 (Plan 33). This property is not served by any highway and the walk from the nearest available permit spaces within Zone 18 is a considerable distance on foot and at a gradient whereas the property actually fronts on to Durley Park and was seemingly included in Zone 18 by virtue of the address with the occupants only becoming inconvenienced when Zone 28 was introduced in August 2023. Numbers 36 and 37 are not affected as they have rear access via Maple Gardens

Westmoreland:

Cllr June Player – Cllr Blackburn and I are fine with Plans 17: 19: 20: 21: 38 & 43.

The following ones however we do have concerns with and give our reasons why:


Plan 14 - Moorland Road Bath - The proposed relocation of the Disabled Parking bay from the south to north side of the road was requested by the local Ward Member to improve accessibility. We are fine with the decision to relocate the Disabled Bay from the South side of Moorland Road to the North side to improve accessibility (due to the double step up to the pavement at this location) however, we would like the word DISABLED marked on the road by this bay. Our reason for this is because the current actual sign 'Blue Badge Holder' is on a small sign which appears too high up to be really noticed plus, it is not always facing the road and so at times, cannot be seen. On numerous occasions vehicles are parked in the bay without a Blue Badge. Improving the signage and having the word DISABLED marked on the pavement should go a long way to solving this issue. We also feel that extra monitoring is needed here as many vehicles just come round the corner from Shaftesbury Rd and then park on the double yellow lines on both these corners which causes problems for other traffic users.

PLAN 18 - Claude Terrace Bath - The proposed extension on Zone 28 was requested by the local Ward member to allow residents of Claude Terrace to be able to purchase permits to park within Resident Parking Zone 28. Being set back from the road, there is no frontage along Claude Avenue in front of these properties for on-street parking. This proposed extension was not requested by either of us, nor discussed with us. Claude Terrace is not in our Ward of Westmoreland, and we cannot accept it because of the negative impact it will have for our Zone 28 residents. Not only will the six properties along Claude Terrace be able to have up to 2 Permits per house but also will be able to purchase Visitor Permits and so take up far more Zone 28 parking spaces to the detriment to our residents who are actually in Zone 28. We appreciate that to access the Claude Terrace properties the occupants do have to walk down a short lane but there is parking provision very close by in Claude Ave, in their Ward. Cllr Blackburn and I have spent many years trying to have the parking issues in our Ward dealt with, for all our residents, including those in Zone 28 at this location.

Response: This was requested by the Southdown Ward Councillors as a result of feedback following the implementation of Zone 28. At the request of the Cabinet Member for Highways the Traffic Management Team will allow this proposal for Claude Terrace to progress to public consultation and then review the feedback received to make an informed decision.

Plan 36 - Monksdale Road Bath - The proposed dual use 3 Hour Limited Waiting Zone/Zone 28 Permit Holder parking bays operating 8am - 6pm were requested by the Traffic Management Team and Local Ward Members from the neighbouring ward to provide additional short term on-street parking provision within the local area. These THREE bays are all in Westmoreland Ward and when this request was put to us, we went and looked at the location and agreed that TWO of these THREE parking bays could provide additional short term on-street parking provision within the local area. We notice however, that all THREE have been marked for this change which we do not agree with. We feel we are being reasonable with our agreement/decision and want to keep the bay nearest to Beckhampton Road as is for our Zone 28 residents.

Response: Please see the amended proposal Plan 36 below to reflect the local Ward Members comments above:



Plan 37 - Bellotts Road Bath - The proposed removal of the existing parking bays and introduction of No Parking At Any Time restrictions was requested by the local Ward Member to improve visibility at the crossing point. Neither of us requested this change. Between us we use this crossing point regularly certainly from Inverness Roadside of it and have never had crossing point issues. We feel that having vehicles parked here actually slows the traffic down in general however, we can see there may be benefit by removing a couple of the parking spaces on the Graveyard side nearest the crossing point to improve visibility and we would be fine with that.

Response: Proposal Plan 37 will be removed from this consultation at the local Ward Members request.

Plan 39 - Cynthia Road/Bridge Road Bath - The proposed dual use 3 Hour Limited Waiting /Zone 28 Permit Holder parking bays operating 8am - 6pm were requested by the Traffic Management Team and local Ward Members to provide additional short term on-street parking

provision within the local area. Neither of us have requested this change. To remove the residents only parking element and open up these spaces to others, seems to be a conflict against those who have paid for their permits and would expect to continue using the spaces available. There has been no request to us to make more spaces available in this area for short term parking plus, being on a Bus Route there are a lot of Double Yellow Lines which have already reduced parking bay provision in this locality for Zone 28 residents.

Response: Proposal Plan 39 will be removed from this consultation at the local Ward Members request.

Cllr Colin Blackburn - As above.

Widcombe & Lyncombe:

Cllr Alison Born - No comment.

Cllr Deborah Collins - As ward councillors for Widcombe and Lyncombe, we object in the strongest terms to the proposal to change the Zone boundary between Zones 4 and 5, marked in the TRO as relating to the Wellsway but actually applying to Wells Rd. Zone 4 properties on Wells Rd suffer from extreme parking stress, whereas Zone 5 has less parking stress. Although a few properties would move over to Zone 5 too, we believe that the overall reduction in parking in Zone 4 would cause unacceptable difficulties for our residents in Zone 4. We were not aware of this proposal so have not had the opportunity to discuss it with the residents concerned but residents have previously raised concerns about the shortage of parking in the area so we do not believe they would support this.

On Hatfield Rd, we appreciate the safety concerns driving the proposal. However, there are now major changes proposed to the parking arrangements on the Wellsway through the Somer Valley Links project. We are also conscious that the changes that we requested through the last South West Area TRO took over a year to implement and therefore the area has not had very much time to adapt to the additional parking that was provided through that. Until the issues created by the Somer Valley Links project are resolved, we are concerned at any loss of parking in this area.

Response: Proposal Plan 31 for the Wellsway, Bath will be removed at the local Ward Members request. Proposal Plan 34 Hatfield Road, Bath will be retained for consultation as these restrictions mainly run in front of a properties dropped kerb so will only be removing 1 to 2 parking spaces on-street to improve visibility splays.

Cabinet Member for Highways:

Cllr Manda Rigby - I am happy for these schemes to go for consultation and look forward to seeing the results of the engagement.

10. RECOMMENDATION

As no significant objections and/or comments have been received following the informal consultation described above, the public advertisement of the Traffic Regulation Order should progress.
















Plan 15 - Roundhill Grove / Mount Road, Bath - The proposed No Parking At Any time restrictions










