INITIAL ALLOCATION STATEMENT FOR ST PHILIP'S PRIMARY SCHOOL

PLACES AVAILABLE: 40

As St Philip's Primary School was oversubscribed it was necessary to use the admissions criteria, as published in 'A Primary School for Your Child – 2020/21', to allocate the places available at the school. Applications for all schools are considered under an equal preference system which means that all preferences (1st, 2nd & 3rd) for each school are considered equally. If there are any cases where more than one of the school preferences named on the application form could have been met only the highest preference school has been allocated.

A total of **102 preferences** were originally received for St Philip's Primary School which has an Admission Number of **40**.

1 place has been offered to a child with a Statement of Special Educational Needs or Education, Health and Care Plan where the school has been named in their statement. This child is included within the Admission Number for the school.

If, under any of the categories listed, places were offered and refused, priority was given to those who live closest to the school as measured in a direct line between the home address and the school.

How the initial allocation of places was made for this particular school:

0 Category A Applicants - Looked after children or previously looked after children

21 Category B Applicants - Siblings. Children for whom there will be a sibling in attendance on the admission date at the preferred school (sibling is defined as sharing at least one parent or legally adopted into the family, and in every case the child should be living in the same family unit at the same address).

1 Category C Applicants – Children of Staff at the School.

Members of staff are full time or part time, either teaching or non-teaching staff employed at the school and who are paid through the school's payroll system.

- a) Where the member of staff has been employed at the school for two or more years at the same time at which the application for admission to the school is made; or
- b) The member of staff is recruited to fill a vacant post for which there is a demonstrable skill shortage.

17 Category D Applicants – Children Not Satisfying a Higher Criteria (proximity). **The furthest direct line distance between the preferred school and the home address offered in this category was 0.353 miles.**

16 children in total have initially been refused a place at St Philip's Primary School. (All other preferences originally considered have qualified for another school as a higher preference)

1 parent originally refused a place has lodged an appeal, 3 parents have opted to just go on the waiting list and 1 late application has been received

All these children were considered for the 1 place available and the place has been offered to:

1 Child in Category D. **The furthest direct line distance between the preferred school and the home address offered in this category in the second round was 0.451 miles.**

These children were all considered for the 1 place available and the place has been offered to 1 child under category D. **The furthest direct line distance between the preferred school and the home address offered in this category was 0.575 miles.**

1 of the places originally offered has become available.

1 parent refused a place has lodged an appeal and 2 parents have opted to just go on the waiting list.

These children were all considered for the 1 place available and the place has been offered to 1 child under category D. **The furthest direct line distance between the preferred school and the home address offered in this category was 1.29 miles.**
