(PUBLIC BRIDLEWAY BC74/1, UNIVERSITY OF BATH, BATHWICK)  
TEMPORARY TRAFFIC REGULATION ORDER 2024**

Bath and North East Somerset Council ("the Council") being the highway authority for Public Bridleway BC74/1, Bathwick, in the County and District of Bath and North East Somerset is satisfied that all traffic over the said bridleway should be restricted because works are being or are proposed to be executed on or near the right of way; namely, Verde Recreo Ltd are proposing to carry out construction works on behalf of the University of Bath.

The Council in exercise of its powers under section 14 of the Road Traffic Regulation Act 1984 and of all other enabling powers hereby makes the following order:

1. No person shall proceed on the section of Public Bridleway BC74/1, Bathwick commencing from grid reference ST 7788 6410 (point A on the order map) and proceeding in a generally north northwesterly direction for approximately 532 metres to a junction with Public Bridleway BC74/3 and Public Footpath BC74/2 at grid reference ST 7774 6458 (point B on the order map).
2. Nothing in Article 1 of this order shall apply to any contractor necessarily proceeding to or from the said works.
3. Nothing in Article 1 of this order shall apply to any pedestrian requiring access to any premises situated on or adjacent to the public path, or to any other premises accessible for pedestrians from, and only from, the public path.
4. This order shall come into operation on 28th March 2024 and will be operative until 1<sup>st</sup> October 2024. The closure will only be effective during that period when signs stating 'Bridleway Closed' are in place on site and only between 7.30 and 18.00 Monday to Friday.
5. The Order may be cited as the Bath and North East Somerset Council (Public Bridleway BC74/1, University of Bath, Bathwick) Temporary Traffic Regulation Order 2024.
