**BATH AND NORTH EAST SOMERSET COUNCIL
(PUBLIC FOOTPATHS CL12/12 AND CL12/31, LITTON RESERVOIRS, HINTON
BLEWETT) TEMPORARY TRAFFIC REGULATION ORDER 2021**

Bath and North East Somerset Council ("the Council") being the highway authority for Public Footpaths (FPs) CL12/12 and CL12/31, Litton Reservoirs, Hinton Blewett in the County and District of Bath and North East Somerset is satisfied that pedestrian traffic over the said footpaths should be restricted because works are being or are proposed to be executed on or near the rights of way; namely, Bristol Water are proposing woodland management works relating to ash dieback within the woodland.

The Council in exercise of its powers under section 14 of the Road Traffic Regulation Act 1984 and of all other enabling powers hereby makes the following order:

1. No person shall proceed over:
 - a) the section of FP CL12/12 commencing from its junction with FP CL12/13 and Whitehouse Lane at grid reference ST 5950 5493 (point A on the closure map) and continuing in a generally northwesterly direction for approximately 850 metres to its junction with FP CL12/31 at grid reference ST 5899 5541 (point B on the closure map); and
 - b) the section of FP CL12/31 commencing from its junction with CL12/12 at grid reference ST 5899 5541 (point B on the closure map) and continuing in a generally westerly direction for approximately 400 metres to its junction with FP CL12/28 at grid reference ST 7633 6173 (point C on the closure map).
2. Nothing in Article 1 of this order shall apply to any contractor necessarily proceeding to or from the said works.
3. This order shall come into operation on 3rd December 2021 and will be operative for a period of 2 months. The closure will only be effective during that period when signs stating 'Footpath Closed' are in place on site. The Order may be cited as the Bath and North East Somerset Council (Public Footpaths CL12/12 and CL12/31, Litton Reservoirs, Hinton Blewett) Temporary Traffic Regulation Order 2021.
